

2020 Rules of the Guardian Gives Back Free HVAC System for Covid19 Front Line workers. No purchase is necessary. You must be at least 18 years or older, owner of the home, legal resident of the United States, be within the Guardian service area and considered a front line worker as stipulated below. The program is void where prohibited. See all eligibility requirements below.

1. **HOW TO ENTER:** No Purchase Necessary. No entry fee, payment, or proof-of-purchase is necessary to participate in the Program. The time to enter the Program begins April 20,2020 and ends May 31, 2020 (the “Entry Period”). Winner will be announced by June 2020. The Program is sponsored, conducted and installed by Guardian Heating & Air Inc. Entries accepted in the online application.

2. By submitting a nominee application, the participant agrees to provide proof of home ownership/residence, proof of employment, and proof of need. Limit one entry per household during the Program Period.

3. **ELIGIBILITY:** You must be at least 18 years or older, owner of the home, legal resident of the United States, be within the Guardian service area and considered a front line worker as stipulated below. The program is void where prohibited. For purposes of this Program, the term “home” must be a single family dwelling that is on a concrete or block slab/basement/ crawl. It must be anchored to the ground with a permanent footing. Entrants may be required to provide proof of legal United States residency, proof of employment, proof of hours worked during the following guidelines as stipulated in the next sentence. Front line workers consist of employees actively working in the following fields during the state of emergency time frame and the state shelter in place time period as set by the state governor of the COVID 19 virus: nurses, doctors, all hospital workers, nursing home and elderly care facility workers, paramedics, police officers, fire fighters, truck drivers, and grocery store workers. Employees of Guardian Heating & Air Inc. or any companies owned by or affiliated, advertising agencies and any other company involved with the design, production, execution or distribution of this Program, or any family or household Members of such employees, officers are not eligible to enter or be selected to participate in the Program. Winner will receive all or some of the following: one 14 SEER conventional gas/ac or heat pump, thermostat and installation. The winner may choose to upgrade any of the equipment to a higher SEER level or quality, or add any additional accessories at their own expense for the parts and possible labor. Guardian Heating & Air Inc does extend any warranty for said work or changes and such upgrades or changes are to be accepted by the Winner “as-is” and without warranty. Winner is solely responsible for all applicable taxes. Guardian Heating & Air Inc makes no representations, guarantees or warranties of any kind whatsoever concerning the appearance or performance of any changes made to a home of the Winner.

SELECTION OF WINNER: Winner will be selected through a comprehensive nomination and screening process that identifies the front line worker with the greatest need and one that can benefit the most from the installation of a new HVAC system. Factors to be considered in selecting the Program winner and finalists may include: size of home, age of current HVAC unit, number of years at present residence, style of home, current energy costs, and number of occupants. The screening process will require the participation of the finalists and occur from June 1 and conclude no later than June 30. The screening process will be performed by the owner of Guardian Heating & Air Inc.
